



Sunsure Energy announces commencement of power supply to APL Apollo in Uttar Pradesh

Apollo Pipes and Apollo Metalex to meet 50% of their power demand through renewable energy, offsetting 7,500 metric tonnes of CO₂e emissions annually

New Delhi, India – July xx, 2024: Sunsure Energy, one of India's leading renewable power producers, announces the commencement of solar power supply to Apollo Pipes Limited and Apollo Metalex Pvt. Ltd., part of the APL Apollo Group (BSE: 533758, NSE: APLAPOLLO), India's largest producer of Structural Steel Tubes and Pipes. Sunsure will be supplying 10.5 million units of renewable energy annually to both the companies from Sunsure's plant in Mahoba, U.P., helping them to collectively offset 7,500 metric tonnes of CO₂e emissions annually, augmenting their sustainability efforts. This will also enable the two companies to meet over 50% of their power requirement with clean, renewable energy, significantly advancing their environmental sustainability initiatives.

With a capacity to produce 3.6 million tonnes per annum, APL Apollo Tubes Limited is the largest producer of Structural Steel Tubes and Pipes in India. APL Apollo has prioritized the Environmental, Social and Governance (ESG) framework by setting ambitious targets, with the vision of achieving net zero emissions by 2050.
