Executive Summary

In FY 2024–25, Sunsure Energy Pvt. Ltd. strengthened its commitment to inclusive development through focused CSR initiatives in education, healthcare, nutrition, sanitation, and community welfare. Guided by the UN Sustainable Development Goals and aligned with flagship programs like Swachh Bharat Abhiyan, National Health Mission, Poshan Abhiyaan, Jal Jeevan Mission, and the National Education Policy, our efforts reached multiple states.

Partnering with credible NGOs, we improved rural school infrastructure for 900+ students, conducted

15 medical camps benefiting 1,800+ villagers, provided monthly aid to over 5,000 elderly, funded 71,000+ mid-day meals for 1,856 children, and empowered 100+ adolescent girls through menstrual hygiene awareness. Our sustainable, grassroots-driven approach created lasting community impact.

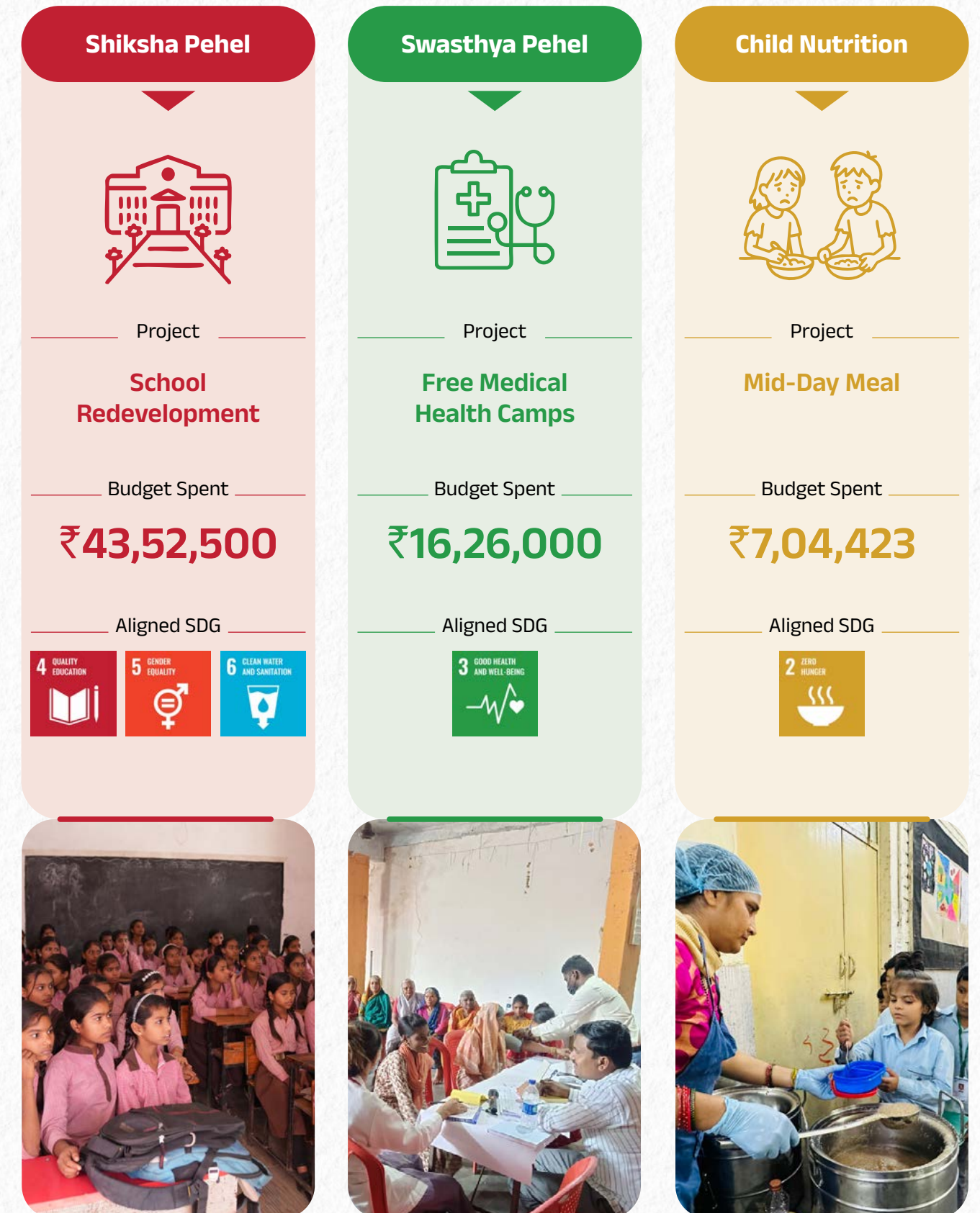

To enhance the learning environment in rural areas, Sunsire partnered with Yuva Unstoppable to reconstruct and upgrade a government school in Augasi. The intervention focused on sanitation, drinking water access, seating infrastructure, and visual learning aids, positively impacting student well-being and learning outcomes.

Health and Well-being Initiatives

At Sunsure, we believe that access to healthcare and dignity in aging are vital to building inclusive and resilient communities. In FY 2024–25, we focused our efforts on delivering grassroots health services and supporting elderly care, especially in underserved regions. Our initiatives, in collaboration with trusted partners like Hand in Hand India and The Earth Saviours Foundation, addressed both immediate medical needs and long-term well-being.

Medical Camps – In Collaboration with Hand in Hand India

In partnership with Hand in Hand India, we conducted **15 Medical Camps** across rural areas of Solapur, Maharashtra. These camps brought essential health services to the doorstep of **1,716 villagers**, including **652 men, 956 women, and 108 children under age of five years**.

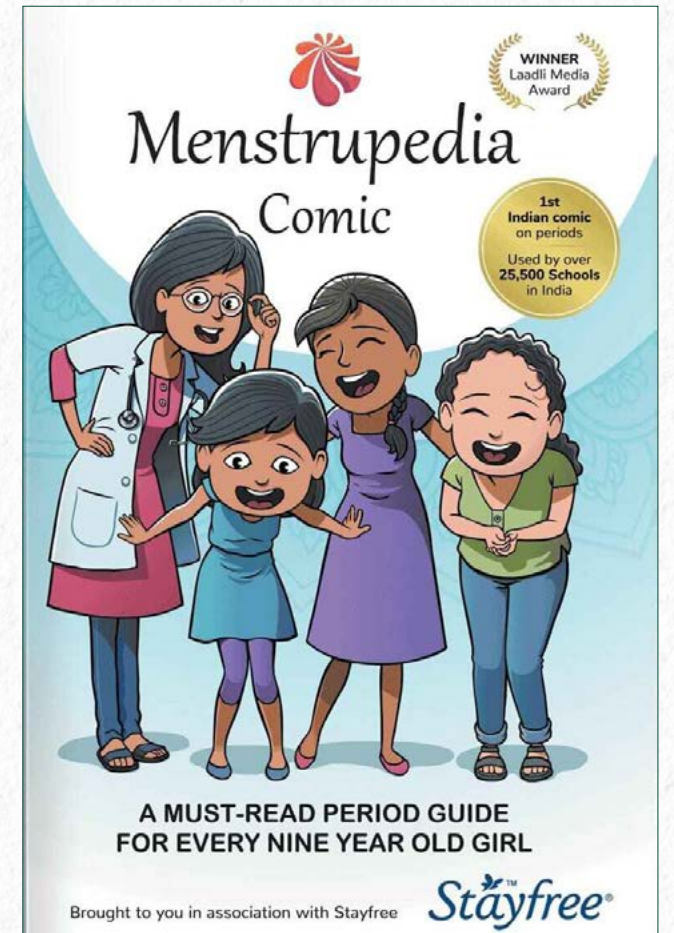
Menstrual Awareness Sessions

As part of our ongoing commitment to SDG 3 (Good Health and Well-being), we conducted a **Menstrual Hygiene Awareness Initiative** in Solapur. This program aimed to educate young women and mothers on menstrual health, break cultural taboos, and promote hygienic practices.

The session consisted of interactive community outreach, and the distribution of sanitary products and Menstrupedia comic. **Menstrupedia Comic** is a guide to educate people around the world, particularly in India in regional languages, on menstruation. It was started by Aditi Gupta. Menstrupedia aims to help people understand the process of puberty in women and men in order to destroy myths around menstruation and normalise the biological process. We distributed 100+ comics (in Marathi) and sanitary pads to promote education and access to hygiene resources. The initiative empowered women with knowledge and resources to manage menstruation safely and with dignity.

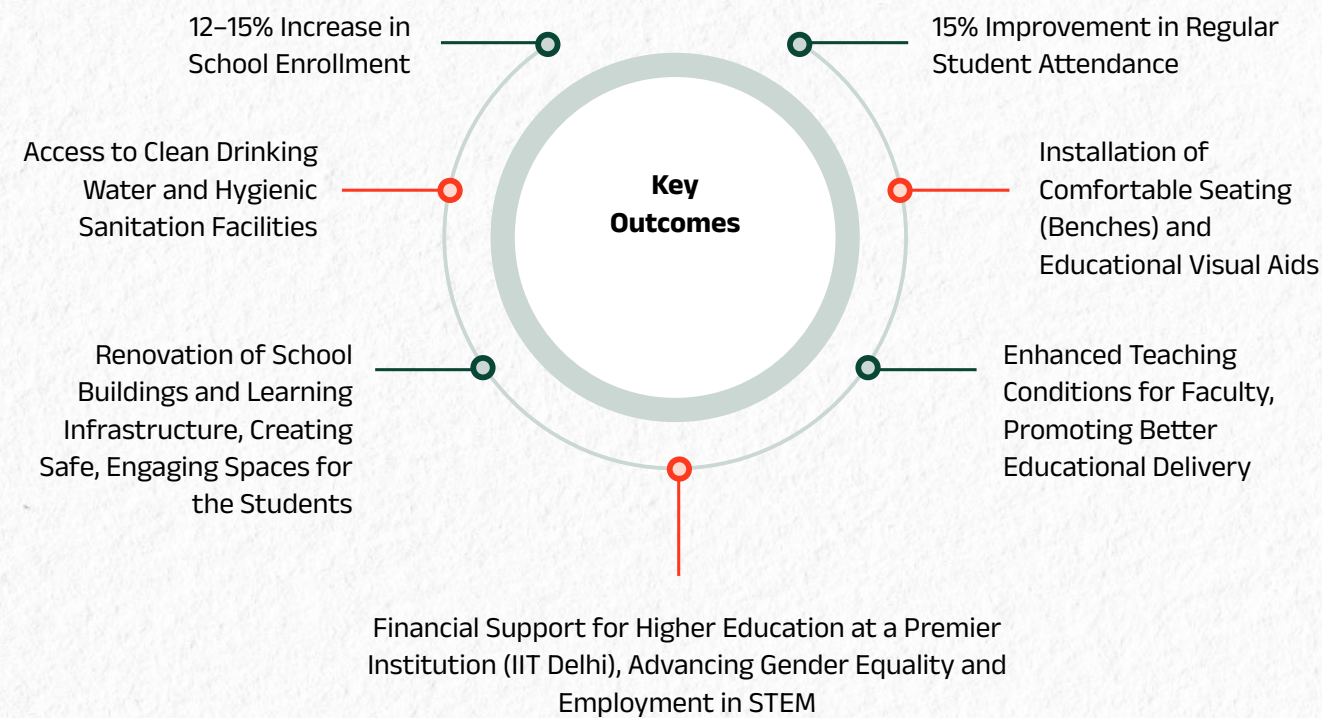

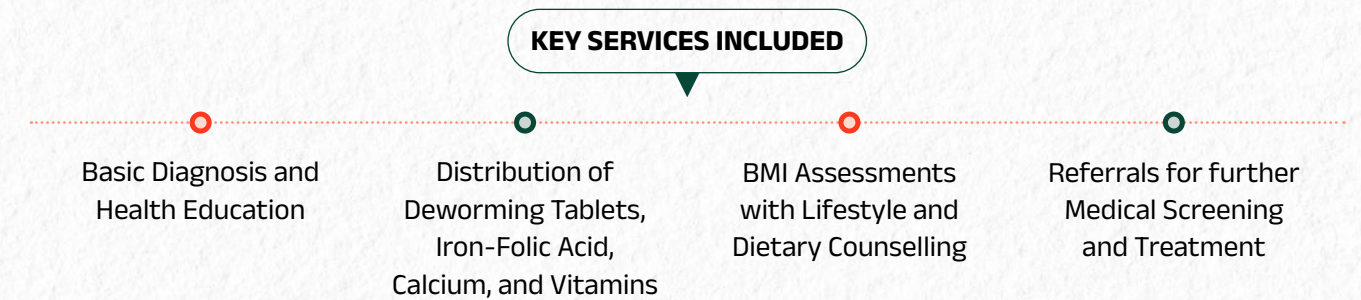

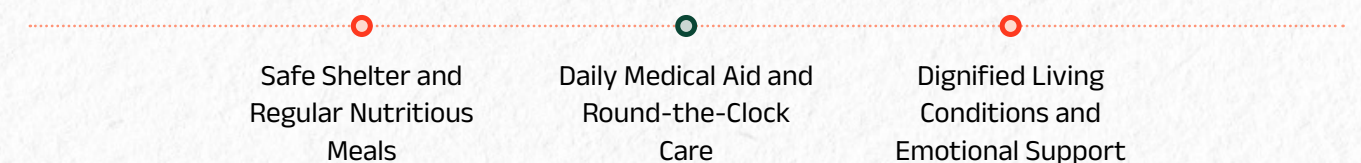
